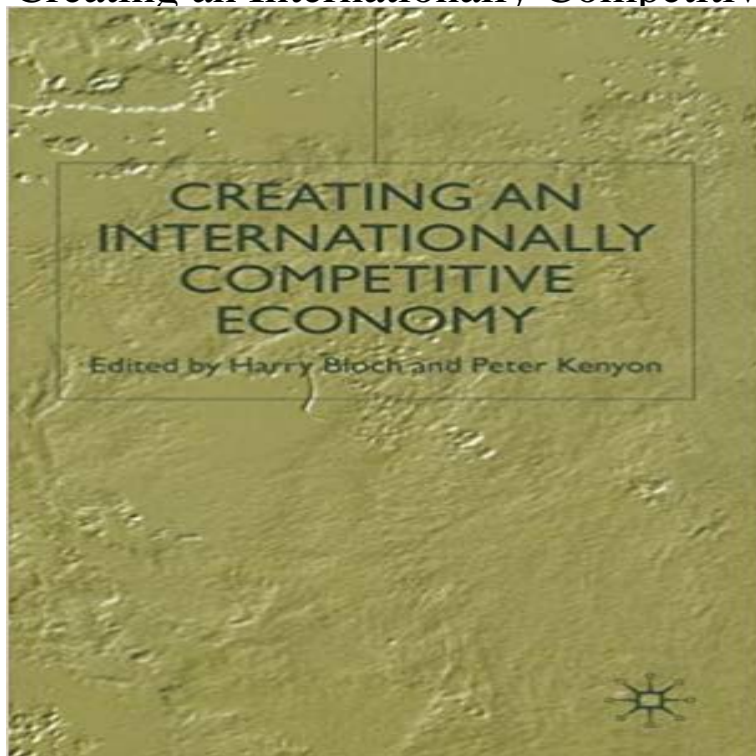


## Creating an Internationally Competitive Economy
