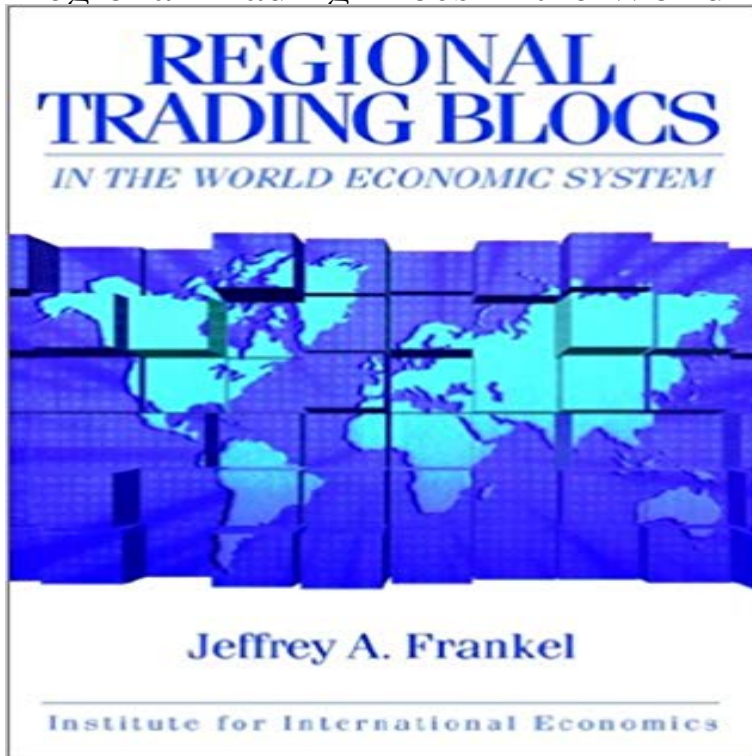


Regional Trading Blocs in the World Economic System
