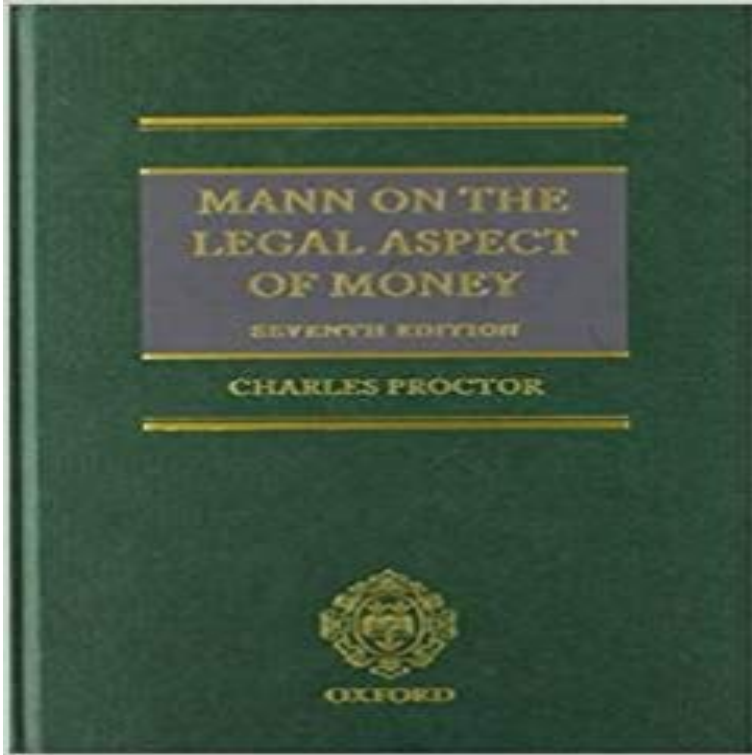


The Legal Aspect of Money: with Special Reference to Comparative Private and Public International Law
